AND WHEREAS the Corporation have agreed to incur the expenses on condition that after successful completion of the course of study the bounden shall serve any of the institution, of the Corporation or of ESI Scheme of the State Government, as the case may be, for a period of two years anywhere in India and also subject to the terms and conditions hereinafter appearing and the bounden and the surety / sureties have agreed to the same.

NOW the condition of the above written obligation is that in the event the Bounden discontinues the study or after completion of the MD/MS Course of study to which he/she was selected, fails to serve the Corporation for period of two years, the Corporation shall have the right to invoke the Bank Guarantee so furnished by the Bounden and sureties.

MEMORANDUM

Posting policy of PG pass-outs (MD / MS / DNB / DM) will be as under:

1. PG (MD / MS / DM) pass-outs (Except in-service candidates):

Out of two years of bond service:

A. Initial 1st year bond service:

- **A.1** They will be posted by their respective Dean at their parent institution immediately after successful completion of the course.
- **A.2** However, they can also be posted / transferred to any other ESIC Medical College.
- **A.3** Posting orders outside the parent institutions would be issued by ESIC Headquarters. Office as per the administrative requirement.

B. PG pass-outs 2nd year bond service:

PG pass-outs may be posted at any of the ESIC Hospitals by ESIC Headquarters. Office as per the administrative requirement.

2. DNB pass-outs (Except in-service candidates):

- **2.1** They will be posted at parent institute immediately after successful completion of the course by the respective Medical Superintendent.
- **2.2** However, they can also be posted / transferred to other ESIC Institutions.
- **2.3** Posting orders outside the parent institutions would be issued by ESIC Headquarters Office as per the administrative requirement.
- **3.** The PG (MD / MS / DNB / DM) pass-outs would also have the option to be posted at any other location as per their choice, in a teaching / non-teaching institution of ESIC. The request option would be considered by a committee at Headquarters office.
- **4.** PG pass-outs will be bound to pay the entire bond amount in case of violation of bond condition irrespective of the period of default.
