AGT application of: MTS

There were two application in which one is eligible for mandatory transfer and the committee recommended the transfer of the following only.

AGT application of: LDC


The committee members found that only 2 LDCs are eligible for mandatory transfer (serial number 2 & 15).




Sr No	Name	Current Posting	Recommendation

AGT application of: SSO


The committee does not recommend transfer of any SSO as inter-regional transfer is being done by the headquarters as communicated in HQtrs Circular dated 18.12.2023.
