As such, PWD candidates other than in the category of **blindness, locomotor disability (both arm affected-BA) and cerebral palsy**, who have availed services of scribe in the Phase I and/or Phase II Exam for the post of **UDC** are required to submit certificate regarding physical limitation to write in the prescribed proforma appended at Annexure - G of the advertisement.
